

Terms & Conditions

Access to and use of the 'Dr Grordbort's Creatures Challenge' is provided by the Weta Limited and CGFeedback (The Promoters) on the following terms:

1. By participating to the Dr Grordbort's Creatures Challenge and submitting entries to the competition, you agree to be bound by these terms, which shall take effect immediately on your first use of the Dr Grordbort's Creatures Challenge. If you do not agree to be bound by all of the following terms please do not access, use and/or contribute to the Dr Grordbort's Creatures Challenge.
2. The Promoters may change these terms from time to time and so you should check these terms regularly. Your continued use of the Dr Grordbort's Creatures Challenge will be deemed acceptance of the updated or amended terms.

Use of Dr Grordbort's Creatures Challenge

3. You agree to participate to the Dr Grordbort's Creatures Challenge only for lawful purposes, and in a way that does not infringe the rights of, restrict or inhibit anyone else's use and enjoyment of the Dr Grordbort's Creatures Challenge. Prohibited behaviour includes harassing or causing distress or inconvenience to any person, transmitting obscene or offensive content or attempting to disrupt the experience of the Dr Grordbort's Creatures Challenge.

Intellectual Property

4. 9. If you do not want to grant The Promoters the permission set out above on these terms, please do not submit or share your contribution to or with the Dr Grordbort's Creatures Challenge.

The Dr Grordbort's Creatures Challenge competition

Any personal information supplied to the Dr Grordbort's Creatures Challenge as part of this registration process and/or any other interaction with the Dr Grordbort's Creatures Challenge will be collected, stored and used for the purpose of the administration of the Dr Grordbort's Creatures Challenge competition and/or in accordance with national and international privacy laws.

16. The failure or delay of The Promoters to exercise or enforce any right in these terms does not waive The Promoters's right to enforce that right.

17. These terms shall be governed by and interpreted in accordance with the laws of New Zealand which shall have exclusive jurisdiction over any disputes.
